I, the undersigned, acknowledge and state that I have voluntarily applied to compete in the 2011 IKF West Coast Classic International Amateur Muay Thai / Kickboxing Championships (Hereafter know as 2011 IKFWCC), on NOVEMBER 25th, 26th & 27th, 2011 at The Radisson Hotel, Sacramento, CA, USA.
- 2: Assumption of risk. I am aware & understand that in general, full contact fighting is a dangerous & hazardous activity, & in particular, the techniques & methods of this convention, all in which as a competitor in this competition, I shall be participating, is an extremely dangerous & hazardous event. I am voluntarily & of my own free will submitting an application to compete in this event with full knowledge & understanding of the hazards involved. I hereby consent & agree to completely accept alone any & all risks of injury or death.
- 3: Release: In consideration for (a) being accepted as a competitor of the 2011 IKFWCC, (b) being entitled to participate in activities conducted and sponsored by the IKF (International Kickboxing Federation and (c) being permitted to use facilities and equipment, whether owned or leased by The IKF and all associates, officials, employees, staff, The Radisson Hotel and fellow participants and trainers/coaches.
